On October 24, 1991, the State of Wisconsin Real Estate Board issued a Final Decision and Order in the above-captioned proceeding. The decision ordered that the real estate license of the respondent, Douglas W. Buettner, be suspended for 60 days commencing November 23, 1991. That decision further ordered that the respondent pay the costs of the proceeding pursuant to sec. 440.22, Wis. Stats.

Respondent's attorney filed a "Petition For Rehearing (Partial)", dated November 15, 1991, in which he requested a rehearing solely upon the issue of the imposition of costs. The petition specifically did not request a rehearing regarding the imposition of a suspension of licensure.

The Real Estate Board was not in a position to discuss or determine petitioner's request for a rehearing on the imposition of costs at its meeting on December 5, 1991. The next meeting of the board is scheduled for January 23, 1992, which is one day after that on which the costs are due to be paid under the Final Decision and Order.

Accordingly, in order to assure that respondent is not responsible for the payment of costs until such time as the board determines respondent's petition for rehearing,

IT IS HEREBY ORDERED, that the portion of the Final Decision and Order dated October 24, 1991 imposing the assessable costs of the proceeding upon the respondent is stayed until further order of the board.

FURTHERMORE, IT IS ORDERED that in all other respects the Final Decision and Order dated October 24, 1991 remains in full force and effect, including the imposition and effective date of the suspension ordered therein.
