ORDER GRANTING LIMITED LICENSE

On November 26, 1990, Dr. Lipman filed his application for a license to practice podiatric medicine and surgery in the State of Wisconsin. By letter dated December 19, 1990, Dr. Lipman was notified that he had failed the oral examination required under Wis. Adm. Code sec. Med 6.05(4). On May 18, 1992, applicant requested reexamination pursuant to Wis. Adm. Code sec. Med 6.06, which was conducted on June 15, 1992. The board considered the application at its meeting of June 24, 1992.

Based upon the application and all other information of record herein, the board makes the following Findings of Fact, Conclusions of Law and Order:

FINDINGS OF FACT

1. Pursuant to Wis. Adm. Code sec. Med 6.05(4), applicant sat for oral examination for licensure on December 10, 1990 and again on June 15, 1992.
2. Applicant failed to demonstrate adequate performance on the oral examination to qualify for a full license to practice podiatric medicine in the State of Wisconsin.

CONCLUSIONS OF LAW

1. The Medical Examining Board has jurisdiction in this matter pursuant to Wis. Stats. sec. 448.05(3) and 448.06.
2. Applicant has failed to demonstrate adequate performance on the oral examination to qualify for a full license to practice podiatric medicine in the State of Wisconsin within the meaning of Wis. Stats. sec. 448.06(1m).

ORDER

NOW, THEREFORE, IT IS ORDERED that Frederick S. Lipman, D.P.M., be, and hereby is, granted a license to practice podiatric medicine and surgery in Wisconsin which shall be limited to restrict Dr. Lipman's podiatric medical practice to non-surgical procedures.

IT IS FURTHER ORDERED that the limitation on Dr. lipman's license shall continue until Dr. Lipman petitions for removal of the limitation and is successful in an oral examination conducted by the Podiatry Examining Council on those areas of practice in which Dr. Lipman has previously demonstrated deficiencies.

NOTICE OF RIGHT TO REQUEST HEARING

PLEASE TAKE NOTICE that pursuant to Wis. Stats. sec. 227.42 and Wis. Adm. Code ch. RL 1, you may have a right to a hearing on the denial of full licensure. You may request such hearing if your request is received in the office of the Medical Examining Board within thirty days of the date hereof. The request must include your name and address, the type of license for which you have applied, the reasons why you have requested a hearing, the facts which you intend to prove at hearing, and an explanation of the mistake you believe was made, if you claim that the denial of full licensure is based on a mistake in fact or law. Within 20 days of receipt of a request for hearing, the board shall grant or deny the request, but the request will be granted if the foregoing requirements are met. If the request for hearing is granted, you will be notified of the time, place and nature of the hearing. If the request for a hearing is denied, you will be notified in writing of the reason for denial.
