The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Sandra E. Ritter (DOB 01-15-72) is duly licensed as a registered nurse in the state of Wisconsin (license #118783). This license was first granted on February 11, 1995.
2. Ms. Ritter's most recent address on file with the Wisconsin Board of Nursing is 228 S. University Dr. #2, West Bend, WI 53095.
3. On March 1, 1998, Ms. Ritter's nursing registration expired. Ms. Ritter did not renew her registration until on or about July 21, 1998. Ms. Ritter admits she worked as a licensed registered nurse at Menomonee Falls Health Care Center, N84 W17049 Menomonee Ave., Menomonee Falls, WI, 53051, during the time her license was expired.
4. In resolution of this matter, Ms. Ritter consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

Sandra E. Ritter, by the conduct described above, has violated sec. 441.07(1)(b), Stats. and Wisconsin Administrative Code § N 7.04(15).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Sandra E. Ritter, is **REPRIMANDED**.

**IT IS FURTHER ORDERED** that within thirty (30) days from the date of this order, Ms. Ritter shall pay the costs of this proceeding in the amount of SEVENTY-FIVE dollars (\$75.00).
