The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Angeline Daniels (DOB 03-28-61), 5222 N. 53rd St., Milwaukee, WI 53218, is duly licensed as a barbering and cosmetology manager in the state of Wisconsin (license #26851). This license was first granted on July 15, 1997.
2. Nefertari Beauty Boutique, 2004 N. Martin Luther King Dr., Milwaukee, WI 53212, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #24099). This license was first granted on March 17, 1995. Angeline Daniels and Trina Moton are listed with the Department of Regulation and Licensing as the owners of Nefertari Beauty Boutique. Trina Moton is listed with the Department of Regulation and Licensing as the manager of Nefertari Beauty Boutique. As owners, Ms. Daniels and Ms. Moton were all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4. Ms. Moton is now deceased.

3. On exact dates unknown, but at least on October 30, 1996, Robyn Rhodes was providing manicuring services at Nefertari Beauty Boutique. At no time relevant to this action did Ms. Rhodes hold a valid and current Wisconsin manicurist license.
4. On exact dates unknown, but at least on June 26, 1998, Danny Donaldson was providing barbering and cosmetology services at Nefertari Beauty Boutique. At no time relevant to this action did Mr. Donaldson hold a valid and current Wisconsin barbering and cosmetology license. Mr. Donaldson was hired by Trina Moton and to the best of Respondent's knowledge, Mr. Donaldson held a valid and current barbering and cosmetology license.
5. Respondent contends in mitigation of these violations that while respondent and Ms. Moton were at all times relevant to this action co-owners of Nefertari Beauty Boutique, respondent held the role of a silent managerial associate and Ms. Moton was the day to day manager for Nefertari Beauty Boutique.
6. In resolution of this matter, Ms. Daniels, d/b/a Nefertari Beauty Boutique, neither admits nor denies liability but consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. By the conduct referred to in ¶ 3-4, above, Angeline Daniels, d/b/a Nefertari Beauty Boutique, violated sec. 454.15(2)(i), Stats. and Wis. Admin. Code § BC 2.04.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Angeline Daniels, d/b/a Nefertari Beauty Boutique, shall pay to the Department of Regulation and Licensing a forfeiture of TWO HUNDRED dollars (\$200.00).

Payment shall be submitted within thirty (30) days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Respondent fails to timely submit payment of the forfeiture as set forth above, the establishment license of Nefertari Beauty Boutique (#24099) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondent has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
