The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Tammy Olson (D.O.B. 11-02-73), P.O. Box 211, Manawa, WI 54949 is duly licensed as a barbering and cosmetology manager in the state of Wisconsin (license #26561). This license was first granted on September 11, 1996.
2. The Hair Shop, 110 2nd St., Manawa, WI 54949, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #26077). This license was first granted on November 15, 1996. Tammy Olson is listed with the Department of Regulation and Licensing as the owner and manager of The Hair Shop. As owner and manager, Ms. Olson was and is at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
3. From October 13, 1998 and continuing on through December 24, 1998, Heather Werth rented a chair from Tammy Olson at The Hair Shop. At no time relevant to this action did Ms. Werth hold a barbering and cosmetology establishment license for the chair he was renting from Ms. Olson.
4. In resolution of this matter, Ms. Olson consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 3-7, above, Tammy Olson, d/b/a The Hair Shop, violated sec. 454.15(2)(i), Stats. and Wis. Admin. Code §§ BC 2.04 and BC 2.06.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Tammy Olson shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within 45 days from the date of this order and shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Tammy Olson fails to timely submit payment of the forfeiture as set forth above, the establishment license of The Hair Shop (#26077) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondents have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
