On March 17th, 1999, the Wisconsin Department of Regulation and Licensing issued an Order Adopting Stipulation granting a limited real estate salesperson's license No. 49937 to applicant Brian N. Woodhull and providing that the limitations imposed by the order may be removed after March 15, 2000 upon compliance with certain conditions and limitations.

The Real Estate Board and the Department of Regulation and Licensing have received information indicating that the applicant met the requirements and other conditions and limitations in the March 17th 1999 Order Adopting Stipulation.

Accordingly, based upon a review of the information received, the Department of Regulation and Licensing issues the following,

ORDER

NOW, THEREFORE, IT IS **ORDERED** that the conditions and limitations previously imposed upon the real estate salesperson's license No. 49937 of Brian N. Woodhull, pursuant to the Order Adopting Stipulation, dated March 17th, 1999, shall be, and hereby are, removed.
