The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Bonnie Happe Geiser, RN (D.O.B. 08/09/39) is duly licensed as a registered nurse in the state of Wisconsin (license #39728). This license was first granted on October 5, 1962.
2. Ms. Geiser's most recent address on file with the Wisconsin Board of Nursing is W309 S8530 Greenview Drive, Mukwonago, WI 53149.
3. At all times relevant to this action, Ms. Geiser was working as a licensed registered nurse at West Allis Memorial Hospital, West Allis, Wisconsin.
4. On or about September 2, 1991, Ms. Geiser in error administered 0.3 cc. of Sus-Phrine intravenously rather than subcutaneously to a patient assigned to her care.
5. Since that time, Ms. Geiser did on her own initiative obtain continuing education in medication administration. This course work is acceptable to the Board for the purposes of professional rehabilitation.
6. In resolution of these proceedings, Ms. Geiser consents to entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct described above, Bonnie Happe Geiser is subject to disciplinary action against her license to practice as a registered nurse in the state of Wisconsin, pursuant to sec. 441.07(1); Stats. and Wisconsin Administrative Code §§N7.03(1)(b) and N.7.04(15).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Bonnie Happe Geiser, RN (license #39728) is REPRIMANDED.

This Order shall become effective on the date of its signing.
