The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following :

FINDINGS OF FACT

1. Thomas C. Blackmon, (DOB 03/01/40; PO 7464, Little Rock, AR 72217) is duly licensed as an auctioneer in the state of Wisconsin (license #1344). This license was granted on March 19, 1998
2. On or about November 25, 1998, Respondent submitted his Auctioneer Renewal Application for the 1999-2000 biennium. . A true and correct copy of Respondent's Auctioneer Renewal Application is attached to this document as Exhibit A. Exhibit A is incorporated by reference into this document. The Department granted Respondent's application for renewal and issued him a registration for the 1999-2000 biennium.
3. At no time relevant to this action has Respondent completed the Wisconsin continuing education requirement for the 1997-1998 biennium, nor has he taken the education examination conducted in lieu of the continuing education requirements. At the time Respondent submitted his renewal application, he did not fully understand the requirements for renewal and did not intend to mislead the Board.
- 4 Based on the conduct referred to in paragraphs 2 and 3 above, Respondent has violated sec. 480.24(2)(a) and (j), Stats. and Wis. Admin. Code RL 128.02.
- 4 In resolution of this matter, Mr. Blackmon consents to the entry of the following Conclusions of Law and Order for the surrender of his license to practice as an auctioneer in Wisconsin. Mr. Blackmon is not at present conducting auctions in Wisconsin.

CONCLUSIONS OF LAW

Based on the conduct referred to in paragraphs 2 and 3 above, Respondent has violated sec. 480.24(2)(a) and (j), Stats. and Wis. Admin. Code RL 128.02.

ORDER

1. NOW, THEREFORE, **IT IS HEREBY ORDERED** that Thomas C. Blackmon shall SURRENDER his Wisconsin Auctioneer's License (license #1344).
2. Should Respondent reapply for Wisconsin licensure, the Board may in its sole discretion determine whether, and under what terms and conditions, this license may be reissued.
3. This Order shall become effective upon the date of its signing.
