On April 27, 2000, the Wisconsin Real Estate Board issued a Final Decision and Order in the above-captioned matter suspending and limiting the license as a real estate broker of David A. Neuville and staying the license suspension for three months on the condition that respondent Neuville participate in a program of supervision with the law offices of Attorneys Robert Ross and Attorney Collin Dahl.

Respondent Neuville has submitted a request for extension of the stay of suspension. Respondent's request is supported by his supervising attorneys.

The Real Estate board, having reviewed the request and the supporting materials, issues the following,

ORDER

NOW, THEREFORE, IT IS ORDERED that the April 27, 2000 Final Decision and Order of the Wisconsin Real Estate Board staying the suspension of the license as a real estate broker of David A. Neuville shall be, and hereby is, extended to October 31, 2000 upon the same conditions and requirements as set forth in the April 27, 2000 Final Decision and Order of the Board.
