FINDINGS OF FACT

- 1. Jamada A. Norris herein (Applicant) whose mailing address is 116 West Washington Ave, Madison, Wisconsin, 53703, holds Limited Private Security Permit No. 11795 which was issued by the State of Wisconsin Department of Regulation and Licensing (Department) under a Stipulation and Order for Issuance of a Limited Permit, a copy of which is annexed hereto.
- 2.. The Order for Issuance of a Limited Permit includes the following provisions:
- "2. Jamada A. Norris shall file with the department quarterly reports within 5

days before or after the following dates:

November 1, 1999

February 1, 2000

May 1, 2000

August 1, 2000

and every November 1, February 1, May 1 and August I until further order of the

department. "

- "8. Failure. by applicant Norris to timely comply with the terms of this limitation shall result in the revocation of his limited private security permit without further notice or hearing or other proceedings."
- 3.. The applicant has failed to file with the department the May 1, 2000 quarterly report required by the terms of the Order for Issuance of a Limited Permit.

CONCLUSIONS OF LAW

A. Applicant has not met the condition in the Order that he file with the department quarterly reports required by

the Order.

B. The Department has authority to issue the following Order under Chapter 440, Stats., and the provisions in the Stipulation and Order For Issuance of Limited Permit.

ORDER

Now, Therefore, It Is Ordered That the Conditional Private Security Permit No. 11795 of

Jamada A. Norris is REVOKED and Applicant Jamada A. Norris shall cease and desist from acting as a private security person and from engaging in private security activities in Wisconsin.

It Is Further Ordered That Applicant shall have an opportunity to challenge the accuracy of the information contained in the Findings of Fact, above by submitting information to the Administrator, Division of Business Licensure and Regulation, P.O. Box 8935, Madison WI 53708-8935 within 10 days after the date of signing, below.

It Is Further Ordered That Revocation of the Applicant's limited private security permit shall become effective on the tenth day after the date of signing, below.

It Is Further Ordered That Applicant shall immediately return the wallet size limited private security permit and the 3 $1/2 \times 5$ 1/4 wall certificate to the Department of Regulation and Licensing, Attention: Marlene Maly, P.O. Box 8935, Madison, WI 53708-8935.
