The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Genevieve Wilcox Meilahn [nka Genevieve Krzysko; DOB 01/03/72], PO Box 554, Green Lake, WI 54941, is duly licensed as a manicurist in the state of Wisconsin (license #957). This license was first granted on August 26, 1991.
2. On exact dates unknown, but at least on June 20, 2000, Genevieve Wilcox Meilahn provided manicuring services at Body Sol, 630 South Street, Madison, Wisconsin.
3. Body & Sol was not at any time prior to June 21, 2000, licensed as a manicuring establishment.
4. In resolution of this matter, Ms. Meilahn consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

Genevieve Wilcox Meilahn, by the conduct referred to in ¶¶ 2 and 3, above, has violated sec. 454.08(1)(b) and 454.15(2)(i), Stats. and Wis. Adm. Code §§ BC 2.045(1) and 3.01(1).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Genevieve Wilcox Meilahn shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within sixty (60) days from the date of this order. *Payment shall be made by certified check or money order*, payable to the Wisconsin Department of Regulation and Licensing and sent to:

**IT IS FURTHER ORDERED** that in the event that Genevieve Wilcox Meilahn fails to timely submit payment of the forfeiture as set forth above, the manager's license of Respondent (#957) SHALL BE SUSPENDED, without further notice or hearing, until Ms. Meilahn has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
