The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Nails Only, 1952 S. Koeller Dr., Oshkosh, WI 54901, was duly licensed as a manicuring establishment in the state of Wisconsin (license #71-1369) on December 14, 1999, This license was first granted on January 15, 1999.
2. Minh Kevin Do (license #82-76131) was listed with the Department of Regulation and Licensing as the owner of Nails Only. As owner, Mr. Do was and is at all times relevant to this action responsible for compliance with ch.454, Statutes. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
3. As owner, Mr. Do was and is at all times relevant to this action responsible for compliance with ch.454, Statutes and Wisconsin Administrative Code chs. BC 2,3, and 4.
4. On exact dates unknown, but at least on December 14, 1999 Respondent employed Ken Nguyen was employed at Nails Only to provide manicuring services to the public at Nails Only. At no time relevant to this action did Mr. Nguyen hold a valid and current Wisconsin manicurist license.

5. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 2, above, Minh Kevin Do, d/b/a Nails Only, violated secs. 454.04 and 454.15 (2)(i) Statutes.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

1. Minh Kevin Do shall pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND dollars (\$1,000.00).

2. *Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:*

3. Payment shall be submitted on the following schedule:

a. Payment #1 of \$100: Shall be made on or before the 15th day of the first month following the effective date of this order.

b. Payment #2 of \$100: Shall be made on or before the 15th day of the second month following the effective date of this order.

c. Payment #3 of \$100: Shall be made on or before the 15th day of the third month following the effective date of this order.

d. Payment #4 of \$100: Shall be made on or before the 15th day of the fourth month following the effective date of this order.

e. Payment #5 of \$100: Shall be made on or before the 15th day of the fifth month following the effective date of this order.

f. Payment #6 of \$100: Shall be made on or before the 15th day of the sixth month following the effective date of this order.

g. Payment #7 of \$100: Shall be made on or before the 15th day of the seventh month following the effective date of this order.

h. Payment #8 of \$100: Shall be made on or before the 15th day of the eighth month following the effective date of this order.

i. Payment #9 of \$100: Shall be made on or before the 15th day of the ninth month following the effective date of this order.

j. Payment #10 of \$100: Shall be made on or before the 15th day of the tenth month following the effective date of this order.

IT IS FURTHER ORDERED that in the event Minh Kevin Do fails to timely submit payment of the forfeiture, as set forth above, the respondent's practitioner license (#82-76131) **SHALL BE SUSPENDED**, without further notice or hearing, until the Respondent has complied with the terms of the Order.

This Order shall become effective upon the date of its signing.
