The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Glamour Shots, 4301 W. Wisconsin Ave., Appleton, WI 54915, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #25803). This license was first granted on June 21, 1996.
2. Roban LLC is the corporate owner of Glamour Shots (license #25803). As owner Respondent is and was at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
3. On exact dates unknown, but at least from July 29, 1998 until February 25, 1999, Respondent operated Glamour Shots without a licensed barbering and cosmetology manager on staff at the establishment. Respondent did recruit for a manager during this period of time.
4. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

Respondent, by the conduct referred to in ¶ 3, above, has violated secs. 454.08(6) and 454.15(2)(i), Stats. and Wis. Admin. Code §§ BC 2.06(5) and 3.02(1).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

1. The Respondent is hereby REPRIMANDED.
2. Within thirty [30] days of the effective date of this Order, Respondent shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). **Payment shall be made by certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

3. In the event Respondent fails to timely submit payment of the forfeiture as set forth above, the establishment license of Glamour Shots (license #25803) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.
4. This Order shall become effective upon the date of its signing.
