ORDER GRANTING FULL LICENSURE

Respondent

On January 29, 1999, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was limited to require that she complete within nine months an approved course of training in the proper use of the Pyxis system. Within two months of the Order, respondent was to have submitted a plan for the required training for approval and, until completion of the approved training program, respondent was to engage in direct patient care only under the direct supervision of another registered nurse, was not to be employed as a pool nurse, and was to provide her nursing employers with a copy of the board's Order. The board's Order was served on respondent by certified mail, return receipt requested, on February 2, 1999; but because respondent had moved on three separate occasions, and failed each time to leave a forwarding address, she did not actually receive the board's Final Decision and Order.

On November 5, 1999, the board considered evidence that respondent had to that date complied with none of the limitations on her license. The board ordered that the license be suspended.

On September 1, 2000, the board considered Ms. Boldus request that her license be reinstated on an unlimited basis. In consideration of evidence that Ms. Boldus has now fully complied with the board's January 29, 1999, Final Decision and Order, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Kathleen M. Boldus, R.N., to practice as a professional nurse in Wisconsin are terminated, and Ms. Boldus is restored to full licensure.
