On February 24, 1999, the Medical Examining Board filed its Final Decision and Order in the above-captioned matter. Under the terms of the board's Order, the board accepted the voluntary surrender of the license of Dr. Asinas effective January 31, 2001, and imposed limitations on the license pending the surrender of the license.

By letter dated December 1, 2000, Dr. Asinas petitioned the board to postpone the date of the surrender of his license for a period of two years, and he appeared before the board on December 20, 2000, in support of his petition.

Based upon the petition, and upon other information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petition of Ildefonso L. Asinas, M.D., for an extension in the deadline for surrendering his license be, and hereby is, denied.

DISCUSSION

At the time Dr. Asinas entered into the Stipulation upon which the board's Final Decision and Order in this matter was based, it was understood that his retirement was imminent. In consideration of his entering into the Stipulation, it was stipulated that the surrender of his license would be delayed until January 31, 2001, to permit the orderly closing of his practice, and stipulated as well that other allegations of misconduct, pertaining to other of his patients, would not be pursued. Dr. Asina's request to delay his retirement is based primarily on his representation that many of his patients have urged him not to retire. Given the total circumstances of this case, particularly the circumstance of a number of other allegations of misconduct which were not pursued in consideration of his retirement, the apparent fact that he has not to date done anything to wind down his practice is insufficient basis for the board to reconsider its Order.
