The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

**FINDINGS OF FACT**

1. Barbara Lee Norberg, RN (DOB 09/10/42), is duly licensed in the state of Wisconsin to practice as a registered nurse (license #81027). This license was first granted on February 8, 1982.
2. Respondent's latest address on file with the Department of Regulation and Licensing is 40 Prairie Road Apt 206, Fond du Lac, WI 54935.
3. The Department of Regulation and Licensing Division of Enforcement is currently conducting an investigation of Respondent based upon allegations of conduct occurring on or about February 22, 2000.
4. Because of health concerns, Respondent has decided to surrender her license in resolution of this investigation. Respondent consents to the issuance of the following Conclusions of Law and Order in resolution of this matter.

**CONCLUSIONS OF LAW**

1. The Wisconsin Board of Nursing has jurisdiction over this matter, pursuant to sec. 441.07, Stats.
2. The Wisconsin Board of Nursing is authorized to enter into the attached stipulation, pursuant to sec. 227.44(5), Stats.

**ORDER**

**NOW, THEREFORE, IT IS HEREBY ORDERED** that

1. The Board of Nursing ACCEPTS the SURRENDER of the license of Barbara Lee Norberg (license #81027) to practice as a Registered nurse in the State of Wisconsin.
2. Should Ms. Norberg reapply for Wisconsin licensure, the Board may determine whether, and under what terms and conditions, this license may be reissued.
3. This Order shall become effective upon the date of its signing.
