The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Model Nails, 4800 Golf Road #804, Eau Claire, WI 54701, is duly licensed as a manicuring establishment in the state of Wisconsin (license #1272). This license was first granted on 08/17/1998.
2. Hoa T. Bui, 4510 Clover Drive, Eau Claire, WI 54701, is listed with the Department of Regulation and Licensing as the owner of Model Nails. As owner, Ms. Bui was and is responsible for compliance with ch. 454, Stats. and chs. BC 2, 3 and 4 of the Wisconsin Administrative Code.
3. Inspection of Model Nails on August 22, 2001 revealed the following deficiencies:
 - a. The establishment was not changing its disinfectant on a daily basis;
 - b. New/clean manicuring implements were stored together with used manicuring tools; and

c. Nail buffers were not promptly discarded after use on each customer.

4. In resolution of this matter, Ms. Bui consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 3, above, Hoa T. Bui, as owner of Model Nails, has violated sec. 454.15(2)(i), Stats., and Wis. Admin. Code §§BC 3.01(1) BC 4.01(1) and BC 4.10(1).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

1. Hoa T. Bui, d/b/a Model Nails (license #1272), is **REPRIMANDED**.

IT IS FURTHER ORDERED that

2. Hoa T. Bui shall pay to the Department of Regulation and Licensing a forfeiture of TWO HUNDRED dollars (\$200.00).

3. Payments shall be due within thirty [30] days from the effective date of this Order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: Department Monitor, Division of Enforcement, PO Box 8935, Madison, WI 53708-8935.

4. In the event Respondent fails to comply with the conditions set forth above, the establishment license of Model Nails (#1272) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.

5. This Order shall become effective upon the date of its signing.
