The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. On October 16, 2000, Isaias E. Mares (Date of Birth: June 20, 1979) was first granted a Private Security Permit (#15809) by the Wisconsin Department of Regulation and Licensing. Mr. Mares' last address known to the Division of Enforcement is Post Office Box 1884, 702 50th Street, Number 1, Kenosha, WI 53141. The Department of Regulation and Licensing has found that Mr. Mares is presently incarcerated at the Kenosha County Detention Center, 4777 88th Avenue, Kenosha, WI 53144.
2. On August 29, 2001, Mr. Mares was convicted in Kenosha County Circuit Court of three charges of Theft-Movable Property (Party to a Crime). A true and correct copy of the Kenosha County Criminal Complaint, Information, Amended Information and Judgment of Conviction is attached as Exhibit A.

3. Mr. Mares at no time reported his August 29, 2001, convictions to the Department of Regulation and Licensing
4. In resolution of this matter, Mr. Mares consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. Failure to notify the Department of Regulation and Licensing of a misdemeanor conviction within 48 hours after the judgment of conviction as described in the above paragraphs is a violation of sec. 440.26(4m)(b) Wis. Stats., and Wisconsin Administrative Code § RL 35.01(2).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

1. The Department of Regulation and Licensing ACCEPTS the SURRENDER of the Private Security Permit of Isaias E. Mares (permit # 15809).
2. IT IS FURTHER ORDERED that should Mr. Mares reapply for a Wisconsin Private Security Permit, the Department of Regulation and Licensing may in its sole discretion determine, whether, and under what terms and conditions, this permit may be reissued.
3. This Order shall become effective upon the date it is signed.
