The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. On September 14, 1999, Leng Xiong (Date of Birth: July 11, 1981) was first granted a Private Security Permit (#12114) by the Wisconsin Department of Regulation and Licensing. Mr. Xiong's last address known to the Division of Enforcement is Post Office Box 080292, Milwaukee, Wisconsin 53208.
2. On November 24, 1999, Mr. Xiong was convicted in Milwaukee County Circuit Court of the misdemeanor charge of Impersonating a Peace Officer. A true and correct copy of the Criminal Complaint and Judgment of Conviction and Sentence to the County Jail/Fine/Forfeiture is attached as Exhibit A.
3. On January 24, 2002, Mr. Xiong was convicted in Milwaukee County Circuit Court of the misdemeanor charge of Disorderly Conduct. A true and correct copy of the Information, Criminal Complaint and Judgment of Conviction is attached as Exhibit B.

4. Mr. Xiong at no time reported his January 24, 2002, conviction to the Department of Regulation and Licensing.
5. In resolution of this matter, Mr. Xiong consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. Failure to notify the Department of Regulation and Licensing of a misdemeanor conviction within 48 hours after the judgment of conviction as described in the above paragraphs is a violation of sec. 440.26(4m)(b) Wis. Stats., and Wisconsin Administrative Code § RL 35.01(2).
2. The Impersonating a Peace Officer conviction substantially relates to the practice of a private security person pursuant to Wisconsin Administrative Code § RL 35.01(2).

**ORDER**

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

1. The Department of Regulation and Licensing ACCEPTS the SURRENDER of the Private Security Permit of Leng Xiong (permit #12114).
2. IT IS FURTHER ORDERED that should Mr. Xiong reapply for a Wisconsin permit, the Department of Regulation and Licensing may in its sole discretion determine, whether, and under what terms and conditions, this permit may be reissued.
3. This Order shall become effective upon the date of its signing.
