On November 12, 2002, the Wisconsin Pharmacy Examining Board reviewed a petition by Duane Asp to remove two limitations from his license, imposed pursuant to a Final Decision and Order ("Order") in case number, LS 970481 PHM, dated effective as of October 14, 1997. The Order was issued by the board pursuant to a stipulated agreement with Mr. Asp. Mr. Asp has requested the removal of two limitations imposed by the Order: 1) that the respondent's license is permanently LIMITED in that he shall not dispense any C-V substance without a valid prescription from an authorized prescriber, and 2) that respondent shall not, before five years from the date of the Order be a managing pharmacist of any pharmacy. ("managing pharmacist" was termed incorrectly by Mr. Asp in his request as "pharmacist in charge".)

Based upon the board's review of the petition:

IT IS ORDERED, the limitation that Mr. Asp not be a managing pharmacist of any pharmacy is hereby REMOVED from his license, number 6675.

IT IS FURTHER ORDERED, that the petition for removal of the limitation that Mr. Asp shall not dispense any C-V substance without a valid prescription from an authorized prescriber is, DENIED.
