The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Charles P. Horton, Respondent, date of birth March 19, 1966, has never been licensed as a boxing club in the State of Wisconsin pursuant to Chapter 444 of the Wisconsin Statutes.
2. Respondent's address is 605 N. 34th Ave. E. Duluth, MN, 55804.
3. Section 444.02, Wis. Stats. prohibits any person from conducting boxing exhibitions in the State of Wisconsin unless the person has a license issued by the Department of Regulation and Licensing, and pursuant to the rules and regulations set forth by the Department.
4. Respondent conducted unlicensed boxing exhibitions at Fat Daddy's in Superior, Wisconsin on February 14, 2003, and at the Solon Springs Community Center in Solon Springs, Wisconsin on March 29, 2003 and June 28, 2003.

CONCLUSIONS OF LAW

1. The Wisconsin Department of Regulation and Licensing has jurisdiction over this matter pursuant to §440.21(1) and (2), Wis. Stats.
2. The Wisconsin Department of Regulation and Licensing is authorized to enter into this stipulated resolution of this matter pursuant to §227.44(5), Wis. Stats.
3. Respondent, Charles P. Horton, has conducted unlicensed boxing matches in Wisconsin in violation of §444.02, Wis. Stats.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Respondent, Charles P. Horton, is prohibited from conducting unlicensed boxing matches without a license in the State of Wisconsin.

IT IS FURTHER ORDERED that Respondent, Charles P. Horton, be, and hereby is, notified that any person who violates a special order such as this, issued under §440.21, Wis. Stats., may be required to forfeit not more than \$10,000.00 for each offense, and that each day of continued violation constitutes a separate offense.
