As reported by the department monitor to the board liaison for monitoring, test results for drug and alcohol monitoring for Lance J. Lundstad evidenced that on May 4, 2005, Lundstad tested positive for ethanol at a rate of .089. The board liaison for monitoring therefore found that Lundstad was in violation of paragraph 2.a. of the board's *Final Decision and Order* dated June 12, 2002. ("*Order*") and on May 19, 2005, terminated the stay of suspension for Lundstad. The liaison also ordered that at the next regularly scheduled meeting of the board, the termination of the stay of suspension of Lundstad would be reviewed by the board for further action. On June 22, 2005, the board reviewed Lundstad's petition to reinstate the stay of suspension as provided by the *Order*.

Based upon the board's review:

IT IS HEREBY ORDERED: that Lance J. Lundstad is denied a three month stay of the suspension of license # 12304, to practice pharmacy in the state of Wisconsin.

IT IS FURTHER ORDERED: that, as a precondition to the granting of a stay of suspension Lance J. Lundstad, shall provide evidence to the board of six (6) months of compliance with all terms and conditions of the *Order* beginning from May 19, 2005, including negative urine drug and alcohol screening which shall include random ETG screening
