On June 8, 2006, the Board of Nursing reviewed the petitioner's request for reinstatement of her stay of suspension, pursuant to her board order dated January 4, 2002. Based upon all information of record herein showing that petitioner has been compliant with her order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that reinstatement of a three month stay of suspension of the license of HOLLY B. LAVOIE, RN (lic. #119837) to practice as a registered nurse is GRANTED.

IT IS FURTHER ORDERED that the frequency of petitioner's screens shall be increased to 118 times per year with ETG testing.

IT IS FURTHER ORDERED that petitioner's therapy shall be increased to two sessions per month and she shall submit quarterly progress reports from her therapist confirming that she is compliant with her therapy.

This order shall be effective upon the date signed below.
