PROCEDURAL HISTORY

On July 12, 2006, the State of Wisconsin Dentistry Examining Board reviewed the petition by Howard J. Lubin, DDS, for an extension of time to complete the continuing education required pursuant to the Board's Final Decision and Order dated July 13, 2005.

FINDINGS OF FACT

1. Howard J. Lubin, D.D.S. (D.O.B. 12/04/1957) is duly licensed as a dentist in the state of Wisconsin (license # 3187). This license first granted on August 1, 1983.
2. Dr. Lubin's most recent address on file with the Wisconsin Dentistry Examining Board is 1505 Woodmont Way, Green Bay, WI 5
3. On July 13, 2005, the Dentistry Examining Board imposed discipline upon the Dr. Lubin's license to practice dentistry.
4. Dr. Lubin has completed the educational requirements imposed by the Board's Order.

CONCLUSIONS OF LAW

The Dentistry Examining Board has jurisdiction and authority in this matter, pursuant to Wis. Stat. § 447.06.

ORDER

IT IS HEREBY ORDERED that the suspension of the license of Howard J. Lubin is terminated. His license is now restored to LIMITED status as per the conditions outlined in the Final Decision & Order dated July 13, 2005.

All other terms and conditions of the Board's order remain in full force and effect, and Dr. Lubin's license is limited in accordance with the terms of the Board's order.
