On November 16, 2006, the Board of Nursing considered the petitioner's request for a three month stay of the suspension of her nursing license; a decrease in her drug screens and a reduction in her therapy sessions. Based upon all information of record herein, showing that the petitioner has been in compliance with terms and conditions of her Board order dated September 8, 2005, and the decrease in her drug screens and therapy is supported by her therapist, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a stay of suspension suspension of the limited license of DAWN MARIE MINESAL, (lic. # 115816) to practice as a registered nurse in Wisconsin, for a period of three months is hereby GRANTED.

IT IS FURTHER ORDERED that petitioner's drug screens shall be decreased to 42 times per year.

IT IS FURTHER ORDERED that petitioner's therapy sessions shall be determined by the therapist but the petitioner's NA/AA meeting attendance shall not be reduced.

This Order is effective upon the date of signing and continuous from the date of the previous stay.
