PROCEDURAL HISTORY

On April 20, 2004, the Department of Regulation and Licensing issued an Order granting Respondent a limited license (#94-6010) to practice as a real estate salesperson in Wisconsin. The Order provided that failure by applicant Petre to timely comply with terms of this limitation would result in the revocation of her limited real estate salesperson's license. The Order also provided that any further criminal conviction (including DWI or OWI) would also result in the revocation of the applicant Petre's limited real estate salesperson's license without further notice, hearing or other proceedings.

Ms Petre has failed to file required quarterly reports with the Department.

Ms. Petre was convicted of Operating While Intoxicated on August 2, 2004.

Ms. Petre was charged with Theft-Movable Property and Possession of Narcotic Drugs on February 27, 2006.

Ms. Petre did not report the conviction or charges to the Department.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the limited real estate salesperson license of Jodi L. Petre (#94-6010) is REVOKED.

This Order shall become effective upon the date of its signing.
