SUMMARY

This Class 1 proceeding was commenced in March 2007 after the applicant requested a hearing following the denial by the Wisconsin Department of Regulation and Licensing of the applicant's application for licensure. A hearing was originally scheduled for June 22, 2007. On June 20, 2007, the Department of Regulation and Licensing received a written request from the applicant that his request for hearing be withdrawn.

FINDINGS OF FACT

1. The applicant, David J. Kennedy, has requested that his request for hearing on the denial of his application for licensure be withdrawn.

ORDER

THEREFORE, IT IS ORDERED that pursuant to RL 1.12 Wis. Admin. Code, the request for hearing on the denial of the application for licensure filed by David J. Kennedy be withdrawn.
