**PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

## FINDINGS OF FACT

1. Accents En Fashion ("Accents") is duly licensed as a barbering and cosmetology establishment in the State of Wisconsin having license #080 0012651. This license was first granted on 08/08/77.

2. Accents' most recent address on file with the Department of Regulation and Licensing ("Department") is: LaPorte Shopping Mall, P.O. Box 55, Manitowish Waters, Wisconsin 54545.

3. Paula-Lou Zeber Chamberlin, date of birth: 05/17/47, is the listed owner of Accents. According to Department Records, Ms. Zeber Chamberlin is also listed as the barbering and cosmetology manager of record for Accents. Ms. Zeber Chamberlin is duly licensed as a barbering and cosmetology manager in the State of Wisconsin having license # 081 0011759. This license was first granted on 07/10/72.

4. Ms. Zeber Chamberlin's most recent business address on file with the Department is: LaPorte Shopping Mall, P.O. Box 55, Manitowish Waters, Wisconsin 54545.

5. As an owner and manager of record, Ms. Zeber Chamberlin was and is at all times relevant to this action responsible for compliance with Wisconsin Statutes, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapter 2.

6. On or about September 23, 2006, the Department received a consumer complaint alleging that unlicensed persons were providing barbering and cosmetology services at Accents.

7. On or about December 15, 2006, an inspection of Accents was performed by a Department investigator. Tina M. Shepski admitted that she provided barbering and cosmetology services at Accents prior to receiving a temporary or apprenticeship permit. Ms. Shepski admitted that she provided barbering and cosmetology services between October 2004 and January 2005.

8. Ms. Shepski was granted a temporary permit (#031-0157) on January 24, 2005 and a barbering and cosmetology practitioner license (#082 84575) on May 25, 2005.

9. The Department was informed that Ms. Shepski was no longer employed by Accents after February 10, 2007.

10. In resolution of this matter, Paula-Lou Zeber Chamberlin and Accents consent to the entry of the following Conclusions of Law and Order.

## CONCLUSIONS OF LAW

1. The Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15.
2. The Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
3. Respondents Paula-Lou Zeber Chamberlin and Accents En Fashion have violated:
  - Wis. Stat. § 454.04(1)(a) and Wis. Admin. Code §§ BC 2.04(1) by permitting an unlicensed person to provide cosmetology services.

## ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondents, Paula-Lou Zeber Chamberlin and Accents En Fashion shall jointly and severally pay to the Department of Regulation and Licensing a forfeiture of **ONE THOUSAND DOLLARS (\$1,000.00)**.

IT IS FURTHER ORDERED, that Respondents, Paula-Lou Zeber Chamberlin and Accents En Fashion shall jointly and severally pay costs in this matter in the amount of **SIX HUNDRED DOLLARS (\$600.00)**.

IT IS FURTHER ORDERED, that a down payment of **SIX HUNDRED DOLLARS (\$600.00)** shall be submitted within thirty (30) days from the date of this order and two more payments of **FIVE HUNDRED DOLLARS (\$500.00)** will be due every three months from the date of the order until the full **ONE THOUSAND SIX HUNDRED DOLLARS** is paid.

IT IS FURTHER ORDERED, that in the event that Paula-Lou Zeber Chamberlin, and Accents En Fashion fails to timely submit payment of the forfeiture and costs as set forth above, Paula-Lou Zeber Chamberlin, barbering and cosmetology manager's license #081 0011759 and Accents En Fashion's barbering and cosmetology establishment license #080 0012651 **SHALL BE SUSPENDED**, without further hearing and without

further Order of the Board, and said suspension shall continue until the full amount of said partial costs has been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file, 06 BAC 112 be, and hereby is, closed as to Respondents Paula-Lou Zeber Chamberlin and Accents En Fashion.

It is hereby stipulated Paul-Lou Zeber Chamberlin, Accents En Fashion, and Attorney Angela L. Arrington for the Department of Regulation and Licensing, Division of Enforcement, as follows:

1. This Stipulation is entered into as a result of a pending investigation of Respondents' licensure by the Division of Enforcement (06 BAC 112). Respondents consent to the resolution of this investigation by Stipulation and without the issuance of a formal complaint.

2. Respondents understand that by the signing of this Stipulation they voluntarily and knowingly waive their rights, including:

- the right to a hearing on the allegations against them, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against them;
- the right to call witnesses on their behalf and to compel their attendance by subpoena;
- the right to testify themselves;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision; and
- the right to petition for rehearing; and all other applicable rights afforded to them under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, and the Wisconsin Administrative Code.

3. Respondents have been provided an opportunity to obtain legal advice prior to signing this stipulation.

4. Respondents agree to the adoption of the attached Final Decision and Order by the Barbering and Cosmetology Examining Board. The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or

consent of the parties. Respondents waive all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall be returned to the Division of Enforcement for further proceedings. In the event that this Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Enforcement and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of the Respondents or their attorney, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with the Board's deliberations on the Stipulation. Additionally, any such Board advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondents are informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.


8. The Division of Enforcement joins Respondents in recommending that the Board adopt this Stipulation and issue the attached Final Decision and Order.
