PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Respondent Christine M. Schmitz (dob 9/29/67) is and was at all times relevant to the facts set forth herein a respiratory care practitioner licensed in the State of Wisconsin pursuant to license #2037, first granted on 1/26/96.
2. On 9/24/06, Respondent was employed at Riverview Hospital, Wisconsin Rapids, Wisconsin, and was on duty from 2 PM to 10 PM. At approximately 9:30 PM, she provided a sample of blood from her body, which was tested and found to contain 0.07% alcohol by weight.
3. Respondent did not have a plausible explanation for this test result.

CONCLUSIONS OF LAW

- A. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- B. The conduct described in ¶2, above, violated Wis. Adm. Code § Med 10.02(2)(i). Such conduct constitutes unprofessional conduct within the meaning of the Code and statutes.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is accepted.

IT IS FURTHER ORDERED, that the SURRENDER of the license to practice respiratory care therapy of Christine M. Schmitz, RCP, is ACCEPTED.

IT IS FURTHER ORDERED, that Respondent shall pay the COSTS of investigating and prosecuting this matter of \$200.
