ORDER DENYING APPLICATION
FOR LICENSURE

On November 14, 2007, the petitioner appeared before the Wisconsin Medical Examining Board to request a license to practice medicine and surgery. The petitioner had been previously disciplined in 1991 and surrendered his license in 1995, pursuant to the Board order dated March 23, 1995, as a result of his second criminal conviction for Sexual assault of a patient. Based upon a review and consideration of all of the information presented, the Board denies the application for licensure due to the severity of the petitioner's prior misconduct and criminal convictions, and hereby orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the application for medical licensure of DANIEL F. CICHON, D.O., is DENIED.

IT IS FURTHER ORDERED that pursuant to the March 23, 1995 order of the Board, the determination of whether to grant licensure shall be in the sole discretion of the Board and the petitioner shall not have any right to be relicensed. Any denial of licensure, in whole or in part shall not be considered a denial for which the petitioner is entitled to a hearing a license pursuant to Wis. States. § 227.01(3)(a) or 227.51.
