On July 16, 2008, the Medical Examining Board considered the petitioner's request to remove the limitations upon his medical license to allow him to participate in a physician re-entry program. Currently, the order of Board dated April 19, 2006, restricts the petitioner from engaging in any form of clinical practice. Based upon the information presented, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request to remove the clinical practice limitations on the medical license of TERRANCE M. SCHEID, M.D. (lic. # 33838-20) is hereby GRANTED as follows:

1. The limitation on petitioner's license regarding clinical practice shall be modified for the sole purpose of allowing him to participate in a board pre-approved physician re-entry program including the clinical portion.
2. Petitioner shall submit information about the selected re-entry program for review and pre-approval by a board liaison prior to the lifting of the clinical practice restriction.
3. Petitioner shall submit documentation upon successful completion of the re-entry program to the Board with a petition for modifications to the order.

This Order is effective upon the date of signing.
