On May 5, 2008, the State of Wisconsin Dentistry Examining Board (Board) reviewed the petition by Dr. Robert B. Pultz, asking the Board to modify the terms of an Order dated January 31, 2007, that imposed discipline on Dr. Pultz. Dr. Pultz asked the Board to reduce his random urine screens. Dr. Pultz also asked to have the number of his required therapy sessions reduced from one a week to one or two a month. The Board reviewed the materials submitted by Dr. Pultz. Based on the review of the record the Board issues the following Order.

IT IS HEREBY ORDERED Dr. Pultz' petition to reduce the number of required random urine screens from 96 to 72 annually is Granted.

IT IS ALSO ORDERED that Dr. Pultz' petition to reduce the number of required therapy sessions from one per week to two per month is Granted.

IT IS ALSO ORDERED that this Order is effective May 5, 2008.
