On September 3, 2008, the Wisconsin Dentistry Examining Board (Board) reviewed Dr. Radke's request for a stay of suspension. He appeared at the meeting to answer questions by Board members. After reviewing the information submitted to the Board and his appearance, the Board decided to grant Dr. Radke a stay of suspension for an indefinite period of time. All of the conditions of the underlying Order dated January 8, 2008, remain in effect.

IT IS HEREBY ORDERED that Dr. Radke's request for a stay of the suspension of his license to practice dentistry is granted for an indefinite period of time.

On May 7, 2008, the State of Wisconsin Dentistry Examining Board (Board) reviewed a petition by Thomas Radke for a stay of suspension as provided in the Board's Final Decision and Order dated January 9, 2008. On May 7, 2008, the Board delegated to the Board's liaison to the Division of Enforcement (DOE) the authority to grant Thomas Radke a stay of suspension effective on or after, June 17, 2008, contingent upon Thomas Radke's compliance with the underlying Order for three months prior to the issuance of a stay. The Board Monitoring Liaison approved the stay effective June 17, 2008, until July 2, 2008, pending further review of the Board.

After careful review of the documents presented to the Board at its July 2, 2008, meeting, the Board has decided to grant a limited stay with conditions to be met by the Board's next meeting on September 3, 2008.

IT IS HEREBY ORDERED that Dr. Radke's petition for a stay of the suspension of his license to practice dentistry in the State of Wisconsin is GRANTED and is in effect from June 16, 2008, to September 3, 2008.

IT IS ALSO ORDERED that Dr. Radke appear before the Board at its September 3, 2008, meeting to answer the Board's questions. Dr. Radke shall also bring with him to the meeting either his supervising dentist or mentor, whichever the Board's DOE liaison decides is most appropriate to act as Dr. Radke's supervisor.

IT IS ALSO ORDERED that Dr. Radke be prepared to answer questions regarding his compliance with two provisions in his underlying Final Decision and Order, dated January 9, 2008. The two provisions are as follows:

C.19. Respondent shall practice only under the general supervision of a dentist approved by the Board or its designee and only in a work setting pre-approved by the Board or its designee.

C.22. It is Respondent's responsibility to arrange for written reports from supervisors to be provided to the Department Monitor on a quarterly basis, as directed by the Department Monitor. These reports shall assess Respondent's work performance, and shall include the number of hours of active dental practice worked during that quarter.
