### PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Barbering and Cosmetology Board ("Board"). The Board has reviewed this Stipulation and considers it acceptable. Accordingly, the Board adopts the attached Stipulation in this matter and makes the following Findings of Fact, Conclusions of Law, and Order:

### FINDINGS OF FACT

1. Sara J. Kucharas is licensed in the State of Wisconsin as a Manicurist, with license number 85-5724. This license was first granted to her on June 9, 2004. Ms. Kucharas's most recent address on file with the Department of Regulation and Licensing ("Department") is 10860 Jewel Road, Arbor Vitae, WI 54568.

2. On June 16, 2008, Departmental Investigator Michelle Krisher conducted an inspection of Unlimited Creations at 10310 Hwy 70 W in Minocqua, Wisconsin.

3. As of the date of the inspection, Unlimited Creations had a lease agreement with Sara Kucharas for a chair rental and Ms. Kucharas had practiced as a manicurist under the lease, but Ms. Kucharas had not obtained an establishment license, in violation of section BC 3.02 (2) of the Wisconsin Administrative Code. Ms. Krisher issued a citation to Ms. Kucharas that carried a forfeiture and costs of \$1000.00.

4. In resolution of this matter, Sara J. Kucharas consents to the entry of the following Conclusions of Law and Order.

### CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Board has jurisdiction to act in this matter pursuant to section 454.15 of the Wisconsin Statutes and is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.

2. Respondent Sara J. Kucharas is subject to discipline for the violation in Finding of Fact 3 above.

### ORDER

NOW, THEREFORE, IT IS ORDERED that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that the Respondent, Sara J. Kucharas, shall pay the forfeiture and costs of \$1,000.00, as follows:  
a payment of no less than \$250.00 shall be due by October 1, 2008, with additional payments of \$250.00 due by January 1, 2009, April 1, 2009, and July 1, 2009.

In the event that the Respondent fails to timely submit payment of the forfeiture and costs as set forth above, her manicurist license **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of the forfeiture and costs has been paid to the Department of Regulation and Licensing.

IT IS FURTHER ORDERED that file 08 BAC 177 be closed.
