The Veterinary Examining Board considered this matter at its meeting on November 19, 2008.

BACKGROUND

On October 25, 2006, the Board issued its Final Decision and Order ("Order") limiting Dr. Runte's license to practice veterinary medicine in the State of Wisconsin, by requiring him to complete eight (8) credits of continuing education in the diagnosis and treatment of acute gastrointestinal conditions and eight (8) credits of continuing education in pharmacology with an emphasis on the use of Rimadyl alone and in combination with steroids, to be completed within one year of the date of the Order. Dr. Runte was also required to insure that when no staff was present for observation of animals hospitalized overnight, that he would provide written and verbal notice of that fact to his clients.

Due to Dr. Runte's compliance with the Order's conditions and based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the license of Dr. Andrew J. Runte, #4870, to practice veterinary medicine in the State of Wisconsin, be and hereby is, fully Reinstated.

The effective date of this Order is November 19, 2008.
