On April 2, 2009, the Wisconsin Board of Nursing considered the petitioner's request for full reinstatement of her nurse license or modifications to the restrictions on her license to grant access, discontinue therapy, decrease drug screens and NA/AA meetings. The request for modifications is made pursuant to the Final Decision and Order dated June 21, 2007. Based upon the information presented which shows that the petitioner has support for some modifications, but that explanatory information is lacking in regard to positive drug screens, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petitioner's request for full reinstatement of the registered nurse license of CHRISTINE R. BOHL, L.P.N., (lic. # 34002) is hereby DENIED.

IT IS FURTHER ORDERED that the following modifications are GRANTED: 1) access to controlled substances for the purpose of administration to patients in her capacity as a licensed nurse at her approved work-site and 2) discontinuation of therapy based upon her therapist recommendation.

IT IS FURTHER ORDERED that the petitioner's request for a decrease in drug screens and weekly attendance of AA/NA meetings is DENIED.

IT IS FURTHER ORDERED that petitioner shall submit an explanation for her positive screens for Tramadol.

The stay of suspension granted pursuant to the original order of the Board shall be continuous until such time as there is a notice of removal for violation of the terms and conditions of the order.
