PROCEDURAL HISTORY

The Wisconsin Chiropractic Examining Board (Board) issued an Order on August 23, 2007 that placed limitations on the Jack Schermerhorn's (Respondent's) license. The Respondent Petitioned the Board for full reinstatement of his license. The Board reviewed his petition at its October 8, 2009 meeting.

FINDINGS OF FACT

The Respondent has complied with the terms of the August 23, 2007 Order.

CONCLUSION OF LAW

The Chiropractic Examining Board has jurisdiction and authority in this matter, pursuant to Wis. Stat., s. 446.03.

ORDER

Based upon the Board's review, IT IS HEREBY ORDERED that the license of Jack Schermerhorn, D.C., to practice Chiropractic in the State of Wisconsin is hereby restored to full and unrestricted status.
