On March 4, 2009, the Wisconsin Dentistry Examining Board granted Gary T. Gross an initial stay of the suspension of his dentistry license (#4318) pursuant to the Board Order dated March 4, 2009. This Order provided that the six month stay is contingent upon his compliance with the terms and conditions of the Board Order.

Information has been received by the Department Monitor that Gary Gross is in violation of the March 4, 2009 Order.

NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension is REMOVED and Gary Gross' license to practice as a dentist (#4318) is SUSPENDED.
