PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision in this matter subject to the approval of the Section. The Section has reviewed this Stipulation and considers it acceptable.

Accordingly, the Section in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

Brad W. Knapp, Respondent, date of birth September 8, 1959, was certified by the Social Worker Section as a advanced practice social worker in the state of Wisconsin, pursuant to certificate number 474, which was first granted June 24 1994. Respondent was granted certification pursuant to the grand-parenting provisions of 1991 Act 160, § 21(2)(b) and fo this reason, did not take the examination otherwise required for certification.

Respondent has not renewed his advanced practice social worker certificate since it expired on June 30, 2007 2. but could renew it pursuant to Wis. Stat. § 440.08(3)(a) and Wis. Adm. Code § MPSW 1.08(2) by payment of fees and proo of completion of continuing education requirements.

Respondent's last address reported to the Department of Regulation and Licensing is 6649 W. Thornapple Drive 3. Janesville, WI 53548.

From December 9, 2005 until his employment was terminated on October 27, 2008, Respondent was employed 4. as a psychotherapist and substance abuse counselor providing individual and group psychotherapy and counseling a Crossroads Counseling Center in Janesville, Wisconsin. Respondent has also been licensed as a Professional Counselor sinc April 2, 2007 and has been certified as a Substance Abuse Counselor-in-Training since October 11, 2006.

From April 4, 2007 to May 20, 2008, Respondent provided individual psychotherapy and counseling to Ms. A 5. approximately twice a month for issues related to depression, alcohol abuse and marital problems/divorce.

During the course of treatment, Respondent and Ms. A developed a personal relationship and began e-mailing 6. each other extensively. In April 2008, Ms. A invited Respondent to visit her at her place of employment. Respondent and Ms

A continued to communicate via e-mail, telephone calls and in person regarding personal matters.

7. Ms. A discontinued treatment after losing her insurance coverage and the last session was May 20, 2007. Respondent and Ms. A engaged in sexual intercourse on May 27, 2008 and on two other occasions over the next couple o months.

8. In October 2008, Ms. A reported to Crossroads that Respondent had a sexual relationship with her. O October 8, 2008, Respondent was placed on administrative leave pending investigation and Respondent's employment wa terminated on October 27, 2008.

9. Respondent admitted that he engaged in sexual conduct with Ms. A shortly after her last treatment session and expressed regret regarding his actions. Respondent entered psychotherapy at Midwest Center for Psychotherapy and Se. Therapy. Respondent has not worked in the mental health field since his employment was terminated at Crossroads.

CONCLUSIONS OF LAW

1. The Social Worker Section of the Wisconsin Marriage and Family Therapy, Professional Counseling and Socia Work Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 457.26(2) and has authority to enter into thi stipulated resolution pursuant to Wis. Stat. § 227.44(5).

2. Respondent, by engaging in sexual conduct with a client within two years of termination of professional services has committed unprofessional conduct as defined by Wis. Admin. Code § MPSW 20.02(11), and is subject to disciplin pursuant to Wis. Stat. § 457.26(2)(f).

<u>ORDER</u>

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. The certificate of Brad W. Knapp, A.P.S.W., Respondent, as an advanced practice social worker in the state o Wisconsin and the right to renew that certificate is hereby SUSPENDED for an indefinite period of time to be no less than eighteen months.

2. Respondent may petition the Social Worker Section for the termination of the suspension, after eighteen months under the following terms and conditions:

a. Respondent shall take an pass all examinations then required for certification.

b. Respondent shall have, at Respondent's own expense, undergone an assessment by a mental health care provider experienced in professionals who have become involved sexually with clients.

c. The practitioner performing the assessment must not have treated Respondent and shall have been approved by the Section, with an opportunity for the Division of Enforcement to make its recommendation, prior to the evaluation being performed.

d. Respondent must provide proof sufficient to the Section that Respondent is able to practice with reasonable skill and safety of clients and public and does not suffer from any condition which prevents him from practicing in that manner.

e. If the Section determines to end the suspension, Respondent's certificate shall be limited in a manner to address any concerns the Section has as a result of the conduct set out in the findings of fact and to address any recommendations resulting from the assessment, including, but not limited to:

1) Psychotherapy, at Respondent's expense, by a therapist approved by the Section, to address specific treatment goals, with periodic reports to the Section by the therapist.

2) Additional professional education in any identified areas of deficiency.

3) Restrictions on the nature of practice or practice setting or requirements for supervision of practice, by a professional approved by the Section, with periodic reports to the Section by the supervisor.

f. Respondent shall have paid the costs of these proceedings in the amount of \$465.00 to the Department o Regulation and Licensing, pursuant to Wis. Stat. § 440.22(2).

3. If Respondent believes that the Section's refusal to end the suspension is inappropriate or that any limitation imposed or maintained by the Section is inappropriate, Respondent may seek a class 1 hearing pursuant to Wis. Stat 227.01(3)(a) in which the burden shall be on Respondent to show that the Section's decision is arbitrary or capricious. The suspension or limitations on Respondent's certificate shall remain in effect until there is a final decision in Respondent's favor or the issue.

5. Violation of any term or condition of this Order, or of any limitation imposed under paragraph 2e above, may constitute grounds for revocation of Respondent's certificate as an advanced practice social worker in Wisconsin. Should the Section determine that there is probable cause to believe that Respondent has violated the terms of this Order, or any limitatio imposed under paragraph 2e above, the Section may order that Respondent's certificate be summarily suspended pendin investigation of and hearing on the alleged violation.

6. This Order is effective on the date of its signing.

It is hereby stipulated and agreed, by and between Brad W. Knapp, Respondent; Kevin F. Milliken of Relles, Long & Milliken, L.L.P., attorneys for Respondent; and John R. Zwieg, attorney for the Complainant, Department of Regulation and Licensing, Division of Enforcement, as follows:

1. This Stipulation is entered into as a result of a pending investigation of Respondent's certification by the Division of Enforcement. Respondent consents to the resolution of this investigation by stipulation and without the issuance of a formal complaint.

2. Respondent understands that by signing this Stipulation, he voluntarily and knowingly waives his rights, including: the right to a hearing on the allegations against him, at which time the state has the burden of proving those allegations by a preponderance of the evidence; the right to confront and cross-examine the witnesses against him; the right to call witnesses on his behalf and to compel their attendance by subpoena; the right to testify himself; the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision; the right to petition for rehearing; and all other applicable rights afforded to him under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and any other provisions of state or federal law.

3. Respondent has obtained advice of legal counsel prior to signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Section. The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Section's Order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Section, the parties shall not be bound by the contents of this Stipulation, and the matter shall be returned to the Division of Enforcement for further proceedings. In the event that this Stipulation is not accepted by the Section, the parties agree not to contend that the Section has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Enforcement and any member of the Section ever assigned as a case advisor in this investigation may appear before the Section in open or closed session, without the presence of Respondent or his attorney, for purposes of speaking in support of this agreement and answering questions that any member of the Section may have in connection with the Section's deliberations on the Stipulation. Additionally, any such case advisor may vote on whether the Section should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Section adopt this Stipulation, the Section's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Enforcement joins Respondent in recommending the Section adopt this Stipulation and issue the attached Final Decision and Order.
