BACKGROUND

On January 9, 2002, the Board issued a Final Decision and Order ("Order") suspending Dr. Blair D. Moldenhauer's license to practice dentistry for an indefinite period of time. Dr. Moldenhauer's license was also limited subject to compliance with numerous requirements. On November 5, 2008, the Board issued an Order Granting a Stay and Modifying Limitations. The November 5, 2008 Order added new limitations to Dr. Moldenhauer's practice of dentistry, including but not limited to, requiring him to have another licensed dentist in the office at all times, who is not an employee.

On November 4, 2009, the Board considered and granted Dr. Moldenhauer's request to modify the November 5, 2008 Order, by allowing him to practice, for one (1) day per week, without the supervision of another licensed dentist. On or about December 11, 2009, Dr. Moldenhauer re-petitioned the Board for an additional increase in the number of hours he may practice without being supervised by another licensed dentist. Based upon all the information of record, the Board orders the following:

ORDER


NOW, THEREFORE, IT IS ORDERED that Dr. Blair D. Moldenhauer's request to modify the Board's November 4, 2009 Order, by increasing the number of hours he is allowed to practice dentistry without the supervision of another licensed dentist to (24) twenty-four hours per week, be and hereby is, Granted.

IT IS FURTHER ORDERED that Dr. Blair D. Moldenhauer, license #3331, shall continue with all other monitoring requirements, including providing samples for two (2) hair tests per year, and is restricted from re-petitioning the Board for a modification for one year.

The effective date of this Order is retroactive to January 6, 2010.
