ORDER FIXING COSTS

On November 5, 2009, the Board of Nursing filed its Final Decision and Order in the above-captioned matter by which the board ordered that pursuant to sec. 440.22, Wis. Stats., the full costs of this proceeding be assessed against Respondent. On or about November 9, 2009, the Board of Nursing received the Affidavits of Costs in the amount of \$4,506.36, filed by Attorney Jeanette C. Lytle. On or about November 17, 2009, the Board of Nursing received the Affidavit of Costs of the Division of Hearings and Appeals in the amount of \$1,035.00, filed by Administrative Law Judge Peter C. Anderson. The total amount of costs for the investigation, prosecution and hearing of this case is \$5, 541.36.

On February 26, 2010, the Board of Nursing received the Respondent's Response to Proposed Assessment of Additional Costs. The Respondent indicated that she did not object to the assessment of full costs, however, she requested that the Board of Nursing provide her with an extension of time to make full payment of costs, an additional 180 days from the date of any order modifying or assessing costs.

The Board of Nursing considered the Affidavits of Costs and the Respondent's Response to Costs, which are hereto attached and made a part of the record in this matter, and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats, the full costs of this proceeding in the amount of \$5,541.36, as set forth in the Affidavits of Costs of Attorney Jeanette C. Lytle and Administrative Law Judge Peter C. Anderson, are hereby assessed against Respondent.

IT IS FURTHER ORDERED that Respondent shall be granted an extension of time of 180 days from the original deadline in the proposed order fixing costs to make full payment of the assessed costs. Accordingly, the costs are due and payable in full by the Respondent by October 21, 2010. Failure of Respondent to make payment on before the extended deadline shall constitute a violation of the order and Respondent's license shall be SUSPENDED without further notice or hearing, until the costs are paid in full together with any accrued interest. In addition, pursuant to sec. 44.22 (3), Wis. Stats., the Department of Regulation and Licensing

may not restore, renew or otherwise issue any credential to the Respondent until payment of the assessed costs are paid in full.
