PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Secretary of the Department. The Secretary has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Secretary adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Savita Jones, (DOB 05/13/1973) is duly licensed as a midwife in the State of Wisconsin (license # 49-11). This license was first granted on April 27, 2007.

2. Respondent's most recent address on file with the Wisconsin Department of Regulation and Licensing is 61440 Argo Road, Mason, WI 54856.

3. Respondent cared for patient R.L. during her prenatal period and during labor. R.L. had had a previous Cesarean section.

4. Despite the previous Cesarean section, Respondent did not consult with a licensed physician or certified nurse-midwife regarding R.L.

CONCLUSIONS OF LAW

1. The Secretary of the Department of Regulation and Licensing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 440.986, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described in paragraph 4 above constitutes a violation of Wisconsin Administrative Code § RL 182.03(4)(b)1t, and subjects Respondent to discipline pursuant to Wis. Stat. § 440.986(2)(e).

ORDER

IT IS ORDERED:

1. Savita Jones is REPRIMANDED

2. The license of Savita Jones to practice as a licensed midwife in the State of Wisconsin is LIMITED as follows:

Within 180 days of the date of this Order, Respondent, at her own expense, shall complete six (6) hours of pre-approved continuing education in midwifery for high risk patients, and six (6) hours of pre-approved continuing education in Wisconsin midwifery laws and ethics. Respondent is responsible for finding appropriate courses and for submitting the course information to the Secretary or her designee for approval prior to taking the course and in sufficient time to complete the courses within the 180 day time frame.

3. Respondent shall, within ninety (90) days from the date of this Order, pay costs of this proceeding in the amount of Six Hundred Dollars (\$600.00). Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:



4. In the event Respondent violates the terms of this Order, including but not limited to failing to pay costs as ordered or failing to comply with the ordered continuing education, the Respondent's license (# 11-049) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.
