**PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Medical Examining Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

**FINDINGS OF FACT**

1. Marta Cristina Muller, M.D., Respondent, date of birth December 17, 1941, holds a license to practice medicine and surgery in the state of Wisconsin pursuant to license number 16603-20, which was first granted November 6, 1968. Respondent practices child and adult psychiatry, and is not certified by any board recognized by the American Board of Medical Specialties. At the time of the events set forth below Respondent was employed as the staff

psychiatrist and medical director at Prader-Willi Homes of Oconomowoc, WI, a facility which provides residential services to some 80 adults with Prader-Willi Syndrome in 8 buildings.

2. From 2002 through 2011, Respondent failed to record her initial psychiatric intake notes, failed to document meetings with patients, and failed to document communications between herself and the primary care practitioners for patients.

### **CONCLUSIONS OF LAW**

A. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 448.02(3) and authority to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).

B. Respondent has engaged in unprofessional conduct as defined by Wis. Admin. Code § MED 10.02(2)(h) and (za), and is subject to discipline pursuant to Wis. Stat. § 448.02(3).

### **ORDER**

NOW THEREFORE IT IS ORDERED that the Stipulation of the parties is hereby accepted.

IT IS FURTHER ORDERED, that the license to practice medicine and surgery of Marta C. Muller, M.D., Respondent, is LIMITED as provided in Wis. Stat. § 448.02(3)(e), and is restricted as follows:

1. Respondent shall not practice clinically until she has demonstrated satisfactory completion of a course in medical recordkeeping. The course or courses attended in satisfaction of this Order must be pre-approved by the Medical Examining Board or its designee. Respondent is responsible for locating a course or courses satisfactory to the Medical Examining Board and for obtaining the required pre-approval of the course or courses from the Medical Examining Board or its designee. The following courses are preapproved, and Respondent may request approval of other courses which are the substantial equivalent of any of these:

- “Intensive Course in Medical Record Keeping with Individual Preceptorships” offered by the Case Western University School of Medicine; or
- “Medical Record Keeping Course” offered by the University of California at San Diego, School of Medicine, Physician Assessment and Clinical Education Program.
- “Patient Care Documentation Seminar” including the Personalized Implementation Program, offered by the Center for Personalized Education for Physicians, Denver, Colorado.

All documents required to be filed with the Medical Examining Board are deemed filed upon receipt by the Department Monitor.


2. Respondent is responsible for paying the full cost of attendance at this course. Respondent may not apply any of the continuing education credits earned in satisfaction of this Order toward completion of the Wis. Stat. § 448.13 biennial training requirements. This Limitation shall be removed from Respondent's license and Respondent will be granted a full, unrestricted license after satisfying the Board or its designee that she has successfully completed all of the ordered continuing education.

IT IS FURTHER ORDERED that:

3. Respondent shall within 90 days of this Order pay the costs of this proceeding in the amount of \$1,100. Payment shall be made to the Wisconsin Department of Safety and Professional Services, and mailed or delivered to the Department Monitor.

4. Violation of any terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered, the Respondent's license may, in the discretion of the board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has paid the costs in full, including any accrued interest.
