The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Alan C. Schold, M.D., (dob August 2, 1941) is licensed in the State of Wisconsin to practice medicine and surgery, having license number 20-44674, first issued on July 8, 2002 with registration current through October 31, 2013. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 5802 W. Melinda Lane, Glendale, Arizona 85308.

2. On May 31, 2012, Respondent and the Commonwealth of Kentucky Board of Medical Licensure entered into an Agreed Order of Indefinite Restriction limiting Respondent's license to practice medicine in the Commonwealth of Kentucky. This action was based on Respondent's inappropriate prescribing practices while working for Central Kentucky Bariatric and Pain Management.

3. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent Alan C. Schold, M.D., engaged in unprofessional conduct pursuant to Wis. Admin. Code § MED 10.02(2)(q) by having discipline taken against his license in another state.

3. As a result of the above conduct, Alan C. Schold, M.D., is subject to discipline pursuant to Wis. Stat. § 448.02(3).

ORDER

1. The attached Stipulation is accepted.

2. Respondent Alan C. Schold, M.D., is REPRIMANDED.

3. The medicine and surgery license issued to Alan C. Schold, M.D., (license number 20-44674) is LIMITED as follows:

a. Respondent, as with the Commonwealth of Kentucky, shall only practice medicine in the specialty of anesthesiology in a perioperative practice environment. As such, Respondent shall only dispense or otherwise professionally utilize controlled substances on patients undergoing surgical/ diagnostic procedures.

b. Respondent is to maintain full and complete compliance with all other terms, limitations, and conditions imposed against his medical license by the Commonwealth of Kentucky Board of Medical Licensure.

c. Respondent shall provide the State of Wisconsin Medical Examining Board with a copy of any document issued by the Commonwealth of Kentucky Board of Medical Licensure which alters the conditions of Respondent's continued practice of medicine in the Commonwealth of Kentucky, including any document advising reinstatement of full licensure. d. In the event Respondent plans to practice medicine and surgery in the State of Wisconsin, he shall notify the Board of his intentions and practice address at least fourteen (14) days prior to his return.

e. Upon Respondent providing proof sufficient to the Board, or its designee, that he has successfully complied with all terms and conditions of the May 31, 2012, Order of the Commonwealth of Kentucky Board of Medical Licensure, the Board or its designee shall issue an Order removing the limitation on Respondent's license.

4. Within 90 days from the date of this Order, Respondent Alan C. Schold, M.D. shall pay COSTS of the matter in the amount of \$75.00.

5. Proof of compliance with the Commonwealth of Kentucky Order and payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Respondent to the Department Monitor at the address below:

6. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of costs as ordered, Respondent's license (no. 20-44674) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of costs.

7. This Order is effective on the date of its signing.
