The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board adopts the attached Stipulation and makes the following Finding of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Tilok Ghose, M.D., (dob September 9, 1957), is licensed in the State of Wisconsin to practice medicine and surgery, having license number 20-55109, first issued on November 8, 2010 with registration current through October 31, 2013. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 17083 Valley Road, Eden Prairie, Minnesota 55347.

¹ The Division of Legal Services and Compliance was formerly known as the Division of Enforcement.

2. On July 14, 2012, the Minnesota Board of Medical Practice issued an order that conditioned and restricted the license of Respondent to practice medicine and surgery in the State of Minnesota. This action was based, in part, on Respondent's failure to appropriately diagnose compartment syndrome and to perform orthopedic surgery in an emergent manner on the patient.

3. In accordance with the Order, Respondent was required, in part, to do the following:

a. Successfully complete coursework addressing the diagnosis and treatment of acute compartment syndrome; and

b. Write and submit a paper for review and approval by the Board discussing what he had learned from the coursework and how he has implemented the knowledge into his practice.

4. On September 8, 2012, the Minnesota Board of Medical Practice issued an Order of Unconditional License reinstating Respondent's license to practice medicine and surgery in the State of Minnesota.

5. Respondent currently has an active license to practice as a physician and surgeon in the State of Minnesota.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation and Order pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent Tilok Ghose, M.D., engaged in unprofessional conduct pursuant to Wis. Admin. Code § Med 10.02(2)(q) by having had disciplinary action taken against his Minnesota license to practice medicine and surgery by the Minnesota Board of Medical Practice.

3. As a result of the above conduct, Respondent Tilok Ghose, M.D., is subject to discipline pursuant to Wis. Stat. § 448.02(3).

ORDER

1. The attached Stipulation is accepted.

2. Respondent Tilok Ghose, M.D., is REPRIMANDED.

IT IS FURTHER ORDERED, effective the date of this order:

3. Within 90 days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$75.00.

4. Payment of costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:



5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered, Respondent's license (20-55109) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.

6. This Order is effective on the date of its signing.
