The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Peter S. Jerome, M.D. (dob August 11, 1955) is licensed in the State of Wisconsin to practice medicine and surgery, having license number 23793-20, first issued on July 1, 1981 and current through October 31, 2013. Peter S. Jerome, M.D.'s most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 2355 Lebanon Road, Frisco, TX 75034.

2. On August 31, 2012, the Texas Medical Board took adverse action against Respondent's Texas license to practice medicine and surgery based on submission of a false or

misleading statement in a license application. The Texas Board imposed a monetary penalty of \$2,000.00.

3. On or about July 5, 2012, when Respondent applied for Texas licensure, he failed to report that between 2003 and 2007, his clinical privileges had been suspended four times at two different hospitals due to delinquent medical records.

4. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3) and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Peter S. Jerome, M.D. violated Wis. Admin Code § MED 10.02(2)(q).

3. As a result of the above violations, Peter S. Jerome, M.D. is subject to discipline pursuant to Wis. Stat. § 448.02(3).

ORDER

1. The attached Stipulation is accepted.

2. Respondent Peter S. Jerome, M.D. is REPRIMANDED.

3. Within 90 days from the date of this Order, Peter S. Jerome, M.D. shall pay COSTS of this matter in the amount of \$100.00.

4. Payment of forfeiture and costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:



5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the forfeiture and costs as ordered, Respondent's license (no. 23793-20) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the forfeiture and costs.

6. This Order is effective on the date of its signing.
