The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Kevin A. Weidman, M.D. (dob August 23, 1951) is licensed in the State of Wisconsin to practice medicine and surgery having license number 20-36166, first issued on December 2, 1994, with registration current through October 31, 2013. Dr. Weidman's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 950 N. 35th Street, Floor 1, Milwaukee, Wisconsin 53208.

2. In February, 2012, Respondent engaged in a series of actions which were disruptive to hospital staff engaged in patient care. Also during this month, Respondent was repeatedly late in providing postoperative orders.

3. In March, 2012, Respondent was diagnosed with bipolar disorder, and placed on an appropriate medication and therapy regimen. Respondent represents to the Board that he is in full compliance with all recommendations of his treating providers.

4. Respondent has, in November, 2012, successfully completed the following: *Intensive Course in Managing Difficult Communications in Medical Practice: Controlling Anger, Avoiding Outbursts, Communicating Appropriately*, offered by the Case Western Reserve University School of Medicine.

#### CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Kevin A. Weidman, M.D. violated Wis. Admin. Code § MED 10.02(2)(h) and (i).

3. As a result of the above violations, Kevin A. Weidman, M.D. is subject to discipline pursuant to Wis. Stat. § 448.02(3).

#### ORDER

1. The attached Stipulation is accepted.

2. The license of Respondent Kevin A. Weidman, M.D. is LIMITED as follows:

a. No later than six months from the date of this order, Respondent shall demonstrate successful completion of an anger management course, which shall have been preapproved by the Board or its designee. The Board finds that the course taken, as described in Finding of Fact 4, above, fully satisfies this requirement.

b. Respondent shall cause his primary therapist to file quarterly reports with the Department Monitor, summarizing his progress in therapy, and current functioning. Respondent shall authorize and request all of his treating health care providers to immediately notify the Department Monitor at any time that his condition may represent a danger to the health, safety, or welfare of patient or public, or that he is unable to practice with skill and safety.

3. Within 60 days from the date of this Order, Kevin A. Weidman, M.D. shall pay COSTS of this matter in the amount of \$450.

4. Payment of costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:

5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered, Respondent's license (no. 20-36166) may, in the discretion of the Board or its designee, be **SUSPENDED**, without further notice or hearing, until Respondent has complied with payment of the costs.

6. This Order is effective on the date of its signing.
