The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Architect Section of the Wisconsin Examining Board of Architects, Landscape Architects, Professional Engineers, Designers, Professional Land Surveyors, and Registered Interior Designers (Section). The Section has reviewed this Stipulation and considers it acceptable.

Accordingly, the Section in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Glenn A. Morrison (Birth Year 1936) is registered by the State of Wisconsin as an architect, having registration number 3003-5, first issued on November 22, 1968

and current through July 31, 2024. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in Minocqua, Wisconsin 54548.

- 2. Respondent Architecture North Ltd. is authorized by the State of Wisconsin as an architectural firm, having certificate of authorization (COA) number 1115-11, first issued on February 7, 1978 and current through January 31, 2024. Respondent's most recent address on file with the Department is in Woodruff, Wisconsin 54568.
- 3. Respondent Glenn A. Morrison is identified in Department records as the responsible licensee in charge of Respondent Architecture North Ltd.
- 4. On May 11, 2022, the Department received a complaint alleging that Respondent Architecture North Ltd. had provided architectural services to the town of Lac du Flambeau, Wisconsin while its COA was expired. The Division of Legal Services and Compliance (DLSC) subsequently opened Case Number 22 ARC 001 for investigation.
 - 5. On February 1, 2018, Architecture North Ltd.'s COA expired.
- 6. In 2019, the town of Lac du Flambeau hired Respondents to perform architectural services.
 - 7. On May 26, 2022, Architecture North Ltd. renewed its COA.
- 8. On June 15, 2022, the Department contacted Respondent Morrison to request a response to the complaint.
- 9. On June 23, 2022, Respondent Morrison responded to the complaint. Respondent Morrison stated that the COA had expired due to an administrative oversight, and that although the COA was expired, his personal license was active the entire time. Respondent stated that as soon as he learned the COA had lapsed, he immediately applied for renewal.
 - 10. On August 1, 2022, Respondent Morrison's credential expired.
- 11. On August 8, 2022, the Department emailed Respondent Morison to ask how many projects Respondent Architecture North Ltd. had worked on while its COA was expired.
 - 12. On August 31, 2022, Respondent Morrison renewed his credential.
- 13. On September 1, 2022, Respondent Morrison replied and stated that Respondent Architecture North Ltd. had worked on approximately 33 projects while its COA was expired.
- 14. On December 7, 2022, the Department emailed Respondent Morrison and asked how many projects he had personally worked on while his credential was expired.
- 15. On December 7, 2022, Respondent Morrison stated that he had worked on one job while his credential was expired.
- 16. On December 13, 2022, Respondent Morrison stated that his credential had expired due to a misunderstanding of the renewal date.

17. In resolution of this matter, Respondents consent to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Architect Section of the Wisconsin Examining Board of Architects, Landscape Architects, Professional Engineers, Designers, Professional Land Surveyors, and Registered Interior Designers has jurisdiction to act in this matter pursuant to Wis. Stat. § 443.11, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent Morrison violated Wis. Stat. § 443.02(2) by practicing architecture while his registration was expired.
- 3. By the conduct described in the Findings of Fact, Respondent Morrison violated Wis. Stat. § 443.08(2)(a)2. by practicing or offering to practice architecture as principal, officer, employee, or agent of a firm when the firm's certificate of authorization was expired.
- 4. By the conduct described in the Findings of Fact, Respondent Architecture North Ltd. violated Wis. Stat. § 443.08(5)(a) by engaging in the practice of or offering to practice architecture in this state, when the firm's certificate of authorization was expired.
- 5. As a result of the above violations, Respondents are subject to discipline pursuant to Wis. Stat. § 443.11(1)(e) and (2).

ORDER

- 1. The attached Stipulation is accepted.
- 2. Respondent Glenn A. Morrison is REPRIMANDED.
- 3. Respondent Architecture North Ltd. is REPRIMANDED.
- 4. Within ninety (90) days from the date of this Order, Respondent Glenn A. Morrison shall pay one-half of the COSTS of this matter, for a total of \$338.
- 5. Within ninety (90) days from the date of this Order, Respondent Architecture North Ltd. shall pay one-half of the COSTS of this matter, for a total of \$338.
- 6. All submissions, including payment of costs (made payable to the Wisconsin Department of Safety and Professional Services), shall be sent by Respondents to the Department Monitor at the address below:

- 7. In the event Respondents violate any term of this Order, Respondents' credentials (numbers 3003-5 and 1115-11), or Respondents' right to renew their credentials, may, in the discretion of the Section or its designee, be SUSPENDED, without further notice or hearing, until Respondents have complied with the terms of the Order. The Section may, in addition and/or in the alternative, refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
 - 8. This Order is effective on the date of its signing.

Respondents Glenn A. Morrison and Architecture North Ltd and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondents consent to the resolution of this investigation by Stipulation.
- 2. Respondents understand that by signing this Stipulation, Respondents voluntarily and knowingly waive the following rights:
 - the right to a hearing on the allegations against Respondents, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondents;
 - the right to call witnesses on Respondents' behalf and to compel their attendance by subpoena;
 - the right to testify on Respondents' own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Respondents under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondents are aware of Respondents' right to seek legal representation and have been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 4. Respondents agree to the adoption of the attached Final Decision and Order by the Architect Section of the Wisconsin Examining Board of Architects, Landscape Architects, Professional Engineers, Professional Land Surveyors, and Registered Interior Designers (Section). The parties to the Stipulation consent to the entry of the attached Final

Decision and Order without further notice, pleading, appearance or consent of the parties. Respondents waive all rights to any appeal of the Section's order, if adopted in the form as attached.

- 5. If the terms of this Stipulation are not acceptable to the Section, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Section, the parties agree not to contend that the Section has been prejudiced or biased in any manner by the consideration of this attempted resolution.
- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Section ever assigned as an advisor in this investigation may appear before the Section in open or closed session, without the presence of Respondents, for purposes of speaking in support of this agreement and answering questions that any member of the Section may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Section should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Respondents are informed that should the Section adopt this Stipulation, the Section's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Legal Services and Compliance joins Respondents in recommending the Section adopt this Stipulation and issue the attached Final Decision and Order.
