Complaint

The State of Wisconsin, Department of Health and Social Services,

Division of Health, Bureau of Environmental Health, by its employee, Dale E.

Parker, complains against the respondent, Harold M. Schneider, and alleges:

- 1. That respondent Harold M. Schneider who resides at 2100 Clarence Avenue, Racine, Wisconsin, 53405 is, and was at all times hereinafter mentioned, duly registered by the Wisconsin Examining Board of Architects, Professional Engineers, Designers and Land Surveyors, under the provisions of Wis. Stat. s. 443.02, as a Land Surveyor, Certificate No. S-351;
- 2. That Dale E. Parker is employed as a Soil Scientist by the Bureau of Environmental Health, Division of Health, Department of Health and Social Services, an agency of the State of Wisconsin, and has been directed by said Bureau to initiate proceedings under Wis. Stat. s. 443.02, to revoke the certificate of registration as a Land Surveyor of Harold M. Schneider;
- 3. On information and belief, that respondent was employed to perform and did perform during the month of June, 1972, soil boring and percolation tests on three lots located on Kraut Road in the SE 1/4 of the NW 1/4, Section 5, T 3N, R22E, Town of Mount Pleasant, Racine County, Wisconsin, owned by Ken Broiher, William Thompson and Peter Vlieger;
- 4. On information and belief, that said soil boring and percolation tests were not conducted according to the procedures required by Wis. Adm. Code s. H 62.20:
- 5. On information and belief, that respondent prepared and signed documents containing soil percolation and soil boring test data for the aforesaid parcels of land;

- 6. That said documents were erroneous and deficient in the following respects:
  - (a) The soil percolation and soil boring test data contained in the documents was not based upon tests performed in accordance with procedures set forth in Wis. Adm. Code s. H 62.20;
  - (b) The soil percolation and soil boring test data contained in the documents did not accurately represent high ground water levels and percolation rates for the aforesaid parcels of land.
- 7. That the performance of soil boring and percolation tests contrary to the procedures required by Wis. Adm. Code H 62.20 and the preparation of documents containing erroneous and deficient test data constitutes misconduct and incompetency in the practice of Land Surveying on the part of respondent and is contrary to Wis. Adm. Code s. A-E 4.06.

WHEREFORE, complainant prays that the certificate of registration as a Land Surveyor of Harold M. Schneider be revoked.

STIPULATION

Respondent.

Harold M. Schneider, respondent, by his attorneys,
LaFollette, Sinykin, Anderson & Abrahamson, and the complainant,
Department of Health and Social Services, by its attorney,
William Dusso, hereby agree and stipulate to the following:

- 1. That the respondent Harold M. Schneider, is registered by the Land Surveyors' Section of the Examining Board of Architects, Professional Engineers, Designers, and Land Surveyors under the provisions of Wis. Stats. §443.02, as a Land Surveyor, Certificate No. S-351.
- 2. That in June, 1972, the respondent performed certain soil boring and soil percolation tests on lands located in the Town of Mount Pleasant, Racine County, Wisconsin and it is alleged by the Department of Health and Social Services that said soil tests were not performed according to the procedures prescribed in Wis. Adm. Code \$H 62.20.
- 3. That the results of certain percolation tests performed by the Department of Health and Social Services on the same lands located in the Town of Mount Pleasant, Racine County, Wisconsin, vary from the results obtained by the respondent, and for the purpose of this proceeding the respondent agrees that the results of said Department's tests shall be accepted as accurate.

- 4. That the respondent hereby waives all jurisdictional of the purisdiction of the Examining Board of Architects, objections to the jurisdiction of the Examining Board of Architects, professional Engineers, Designers and Land Surveyors to hear the complaint of the Department of Health and Social Services and to enforce the rules of said Department.
- 5. That the respondent agrees to accept a formal reprimand from the Land Surveyors' Section of the Examining Board of Architects, Professional Engineers, Designers and Land Surveyors respecting such soil percolation tests and agrees not to perform any soil boring or soil percolation tests in any manner whatsoever until after December 31, 1975, and then only pursuant to such rules as may then be in force.
- proceedings in any manner; agrees to accept the formal reprimand of the Land Surveyors' Section of the Examining Board of Architects, Professional Engineers, Designers, and Land Surveyors; agrees that for the purpose of this proceeding any deficiency whatsoever in the performance of any soil tests may be denominated as misconduct or gross negligence or incompetence in the practice of land surveying; waives any and all rights whatsoever to object to this proceeding; waives the right to present any defense whatsoever to the complaint of the Department of Health and Social Services; and generally acquiesces in the power and jurisdiction of the aforesaid Examining Board to act in accordance with this Stipulation.
