Joseph Dedinsky, D.D.S.

This matter having come to hearing on April 27, 1976, upon motion of the State of Wisconsin Department of Regulation and Licensing, and upon the stipulation attached hereto, IT IS HEREBY ORDERED THAT:

Dr. Joseph Dedinsky be and hereby is formally reprimanded for the following violation:

That between November, 1972 and March, 1976, Dr. Dedinsky failed to meet minimal professional standards of sanitation and hygiene; and that such failure constitutes conduct unbecoming a professional man, as prohibited by section 447.07 of the Wisconsin Statutes.

IT IS FURTHER ORDERED THAT Dr. Dedinsky be placed on an eighteen (18) month term of probationary review, commencing June 4, 1976 at 5:00 P.M. As conditions of such probation, Dr. Dedinsky shall:

- (a) By June 4, 1976, provide the Board with a written statement outlining those steps he intends to take to improve the sanitary and hygienic conditions of his office.
- (b) Commencing June 4, 1976, report at six (6) month intervals in writing or in person to the Board as to those steps he is taking to maintain professionally adequate hygienic and sanitary conditions in his office.
- (c) During the above eighteen (18) month period, permit members of the Dentistry Examining Board, or their designees to fully inspect Dr. Dedinsky's dental offices at reasonable times during working hours without prior notice.
- (d) By June 4, 1976, or as soon thereafter as possible, employ a full-time dental hygienist or dental assistant who will be present in Dr. Dedinsky's office during working hours.

Dr. Joseph Dedinsky, personally, and by his attorney Paul Sicula, and the Department of Regulation and Licensing, by Attorney Hal Harlowe, stipulate to the entry of an order in the above-captioned case providing for the following:

- (1) That upon this stipulation, and without further testimony, the Dentistry Examining Board find as follows:
 - (a) That Joseph Dedinsky, D.D.S. is a dentist duly licensed to practice dentistry in the State of Wisconsin; that he holds license number 149E; and that his offices are located at 2629 West Greenfield Avenue, Milwaukee, Wisconsin;
 - (b) That between November, 1972 and March, 1976, Dr. Dedinsky failed to maintain his office so as to meet minimal professional standards of sanitation and hygiene; and that such failure, constitutes conduct unbecoming a professional man, as prohibited by sections 447.07(3) and (5) of the Wisconsin Statutes.
- (2) That Dr. Dedinsky be formally reprimanded by the State of Wisconsin Dentistry Examining Board for the above violation;
- (3) Further, that the Board place Dr. Dedinsky on an 18 month term of probationary review, commencing June 4, 1976 at 5:00 p.m. As conditions of such probation, Dr. Dedinsky shall:
 - (a) By June 4, 1976, provide the Board with a written statement outlining those steps he intends to take to improve the sanitary and hygienic conditions of his office.
 - (b) Commencing June 4, 1976 report at six month intervals in writing or in person to the Board as to those steps he is taking to maintain professionally adequate hygienic and sanitary conditions in his office.
 - (c) During the above 18 month period, permit members of the Dentistry Examining Board, or their designees to fully inspect Dr. Dedinsky's dental offices at reasonable times during working hours without prior notice.
 - (d) By June 4, 1976 or as soon thereafter as possible, employ a full-time dental hygienist or dental assistant who will be present in Dr. Dedinsky's office during working hours.

The parties hereto agree and understand that the above requested order would be entered in lieu of an order of revocation or suspension pursuant to section 447.07 of the Wisconsin Statutes.
